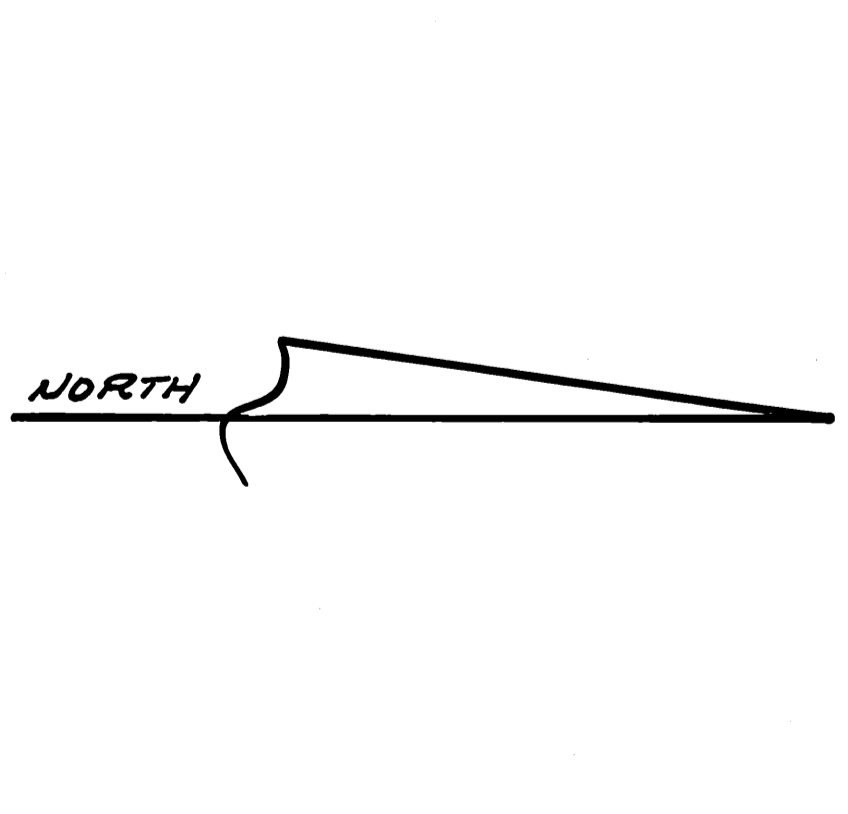


CLOSING CORNER - FOUND REBAR CAP PER BOOK 21 OF SURVEYS PT PAGES 184-192

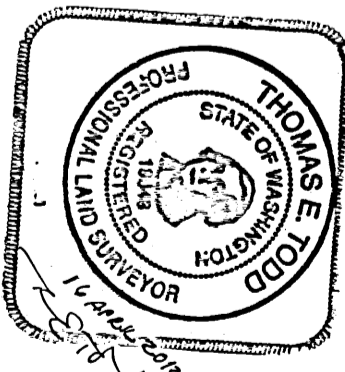
