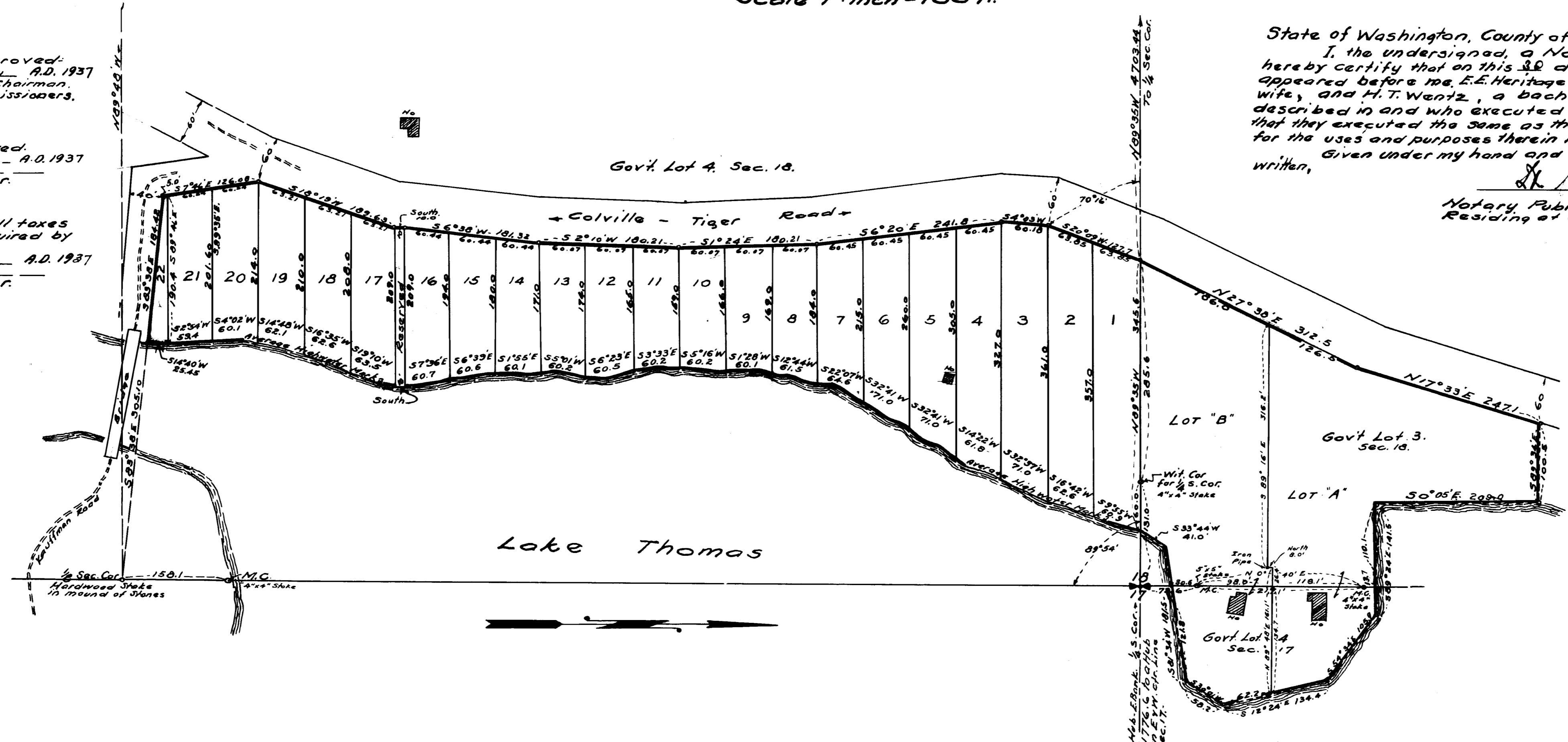
Lots 3 and 4, Section 18, Twp. 36, N.R. 42, E.W.M.
